Republic Act 11223 or the Universal Health Care Act recognizes the critical role of school communities in enabling healthy behaviors within their jurisdiction by designating all schools under the supervision of the Department of Education (DepEd) as healthy settings. The Department of Health (DOH), in partnership with national education agencies, implement Joint Administrative Order (JAO) No. 2022-0001 or the "Guidelines on Healthy Settings Framework in Healthy Learning Institution" in support of this mandate.

The JAO states that DepEd, in coordination with the DOH, shall develop and maintain a recognition or compliance system for individual institutions to be recognized as healthy learning institutions. Hence, the "Healthy Pilipinas Awards for Basic Education Institutions 2024."


