This has reference to your letter requesting permission to conduct a lecture-forum on environmental protection and preservation about “Climate Resilient Human Settlements” during the Brigada Eskwela.

Relative to this, please be informed of the following:

1. That the Brigada Eskwela shall be conducted from July 22 to 27, 2024 as stipulated in **DepEd Order No. 003, s. 2024**, titled, “Amendments to DepEd Order No. 22, s. 2023 (Implementing Guidelines on the School Calendar and Activities for the School Year 2023-2024)”;
