

Temporary Suspension of the Registration and Administration of Walk-In Philippine Educational Placement Test (PEPT) at the DepEd Central Office

1. In line with the Administration of the 2024 Special Philippine Educational Placement Test (PEPT) to select regions and divisions with designated testing centers on August 4, 2024 (Luzon Cluster) and August 11, 2024 (Visayas and Mindanao Cluster), this Bureau would like to announce the temporary suspension of the registration of applicants for walk-in PEPT at DepEd Central Office starting July 29, 2024.
2. The temporary suspension also provides an avenue for the Bureau to review and evaluate existing processes and documentary requirements for better clientele servicing.
3. Test registrants who need to take the PEPT may opt to visit the nearest Schools Division Offices (SDOs) to register for the 2024 Special PEPT administration. The Division Testing Coordinators (DTCs) shall be in charge of evaluating the documentary requirements of the test registrants.
4. The provision of onsite administration of PEPT for test registrants coming from schools without government permits can still be accommodated in coordination with the DTCs. The specific guidelines of the onsite PEPT are stated in the DepEd Order No. 23, s. 2019 titled *Additional Provisions to Section 6: Grade Level Placement Assessment of DepEd Order No. 53, s. 2016 and DM/OM-CI-2022-00273* titled *Onsite Administration of the Philippine Educational Placement Test (PEPT) and Other Regular Assessment Services*.
