





Subject: Invitation to attend to an Online Workshop for COMPLIANCE CHECK AND DATA PROTECTION STANDARDS

Dear Sir/Madam,

Greetings!

We would like to invite you and department heads/officers and data privacy team that already attended our Data Privacy Workshop to attend to our online workshop entitled "Compliance Check and Data Protection Standards".

Section 3D of NPC Circular 18-02 states that Compliance Check refers to the systematic and impartial evaluation of a Personal Information Controller (PIC) or Personal Information Processors (PIP), in whole or any part, process or aspect thereof, to determine whether activities that involve the processing of personal data are carried out in accordance with the standards mandated by the Data Privacy Act and other issuances by the Commission.

The learning objectives of this training is to enable the agency or private organization understand what the NPC guidelines are with regards to the conduct of compliance check, the mode of compliance, and when the conduct of compliance check will happen. Topics on the General Protection Rule (GDPR) and Data Privacy Law in the Philippines will be discussed by our data privacy managers, PECB ISO/IEC 27701 Lead Auditor and data privacy expert and how each user can benefit from it.

Failure to Comply with Compliance Order per Section 12 of NPC Circular 18-02 may subject to criminal, civil or administrative penalties, without prejudice to other remedies available under the law.

Section 2 of Circular 21 states that administrative sanctions, fines, or penalties will be imposed for violations of R.A. No. 10173, Its Implementing Rules and Regulations (IRR), and other issuances and orders of the Commission. The number of fines will be determined in accordance with the factors enumerated under Section 3. As per Tier 1 of Section 2, administrative fines of 1% to 5% of the annual gross income shall be imposed to any natural or juridical person processing personal data that infringes on the provisions and Implementing issuances by the Commission.
