**DISSEMINATION OF REPUBLIC ACT NO. 12009 (AN ACT REVISING REPUBLIC ACT 9184 OTHERWISE KNOWN AS THE GOVERNMENT PROCUREMENT REFORM ACT, AND FOR OTHER PURPOSES)**

1. The Congress of the Philippines enacted RA No. 12009 revising RA No. 9184 otherwise known as the Government Procurement Reform Act.
2. In line with this, this office reminds all personnel to keep abreast of the revisions in the procurement process.
3. Pertinent revisions are provided in Art. II Sec. 10 on Market Scoping as a preliminary undertaking prior to the preparation of Project Procurement Management Plan.
4. Attention is also invited to Art. IV on the different Modes of Procurement and its conditions, to wit:
  - a. Competitive Bidding;
  - b. Limited Source Bidding;
  - c. Competitive Dialogue;
  - d. Unsolicited Offer with Bid Matching;
  - e. Direct Contracting;
  - f. Direct Acquisition;
  - g. Repeat Order;
  - h. Small Value Procurement;
  - i. Negotiated Procurement;
  - j. Direct Sales; and
  - k. Direct Procurement for Science, Technology and Innovation.
