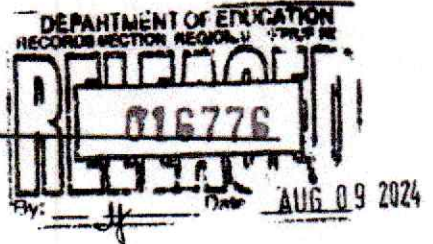



Dear Director Aquino:

The whole bureaucracy will be celebrating the 2024 Philippine Civil Service Anniversary on September 2024 with an array of activities lined up for this whole-month celebration in which we are calling and requesting for the participation and engagement of all agencies in the region.

Among these activities are the following:

1. VibeRun – a color-filled fun run to be held on September 1, 2024 (Sunday) at the Baywalk, Poro Point, San Fernando City for the La Union participants, at the Narciso Ramos Sports Stadium for the Pangasinan participants, at the Quirino Stadium, Bantay, Ilocos Sur for the Ilocos Sur participants, and at the Aurora Park in Laoag City for Ilocos Norte participants. This will serve as the kick-off activity for the month-long celebration. A registration fee of P 250 is requested to be paid by the participants where the proceeds will go to the Pamana ng Lingkod Bayani administered by the Civil Service Commission for the benefit of government workers who died in the line of duty.
2. Tree Growing For a Cause – to be held on September 17, 2024 (Tuesday) which is intended to arouse and deepen the environmental consciousness of our government workers where they will plant, replant, nurture and monitor the growth of planted seedlings at the following planting sites:

Daang Kalikasan Mangatarem, Pangasinan	For Pangasinan participants
Agoo Eco-Park Agoo, La Union	For La Union Participants
Botanical Garden Daclapan, San Fernando City, La Union	For La Union Participants
Brgy. Dallgan, Sta. Cruz, Ilocos Sur	For Ilocos Sur participants
Brgy. 56B, Bacsil South, Laoag City Brgy. San Gristobal, Sarrat, Ilocos Norte	For Ilocos Norte participants

Just like the Viberun, the Tree Growing For a Cause requires a registration fee of P250.00 which will be remitted to the Pamana ng Lingkod Bayani.

3. **Blood Letting** – to generate sufficient bags of blood for the National Blood Bank of the Ilocos Training Regional Medical Center to be held on September 10, 2024 (Tuesday) at the CSCRE1's Hall of Learning.
4. **Medical Mission** – to be held on September 12, 2024 (Thursday) as a way of extending assistance and deliver fundamental medical care to disadvantaged and marginalized sectors of the community. The beneficiaries of this year's medical mission are the children and teenagers who have been isolated from their families due to sexual abuse or exploitation and have sought refuge at the Home for Girls at San Nicolas, Agoo, La Union.

In order to drum up support to these activities, we requested the Professional Regulation Commission for the grant of CPD Units to all professionals who will participate in any or all of the above-enumerated activities. Further, as sanctioned by the Civil Service Commission, all government workers who will participate in these activities may be allowed to avail of Compensatory Time Off (CTO) equivalent to the number of hours spent in joining these activities during weekends or non-working days.

There is clamor however, that on the part of DepEd Teachers who will be permitted to join any or all these activities that, in lieu of the CTO, they should be given service credits inasmuch as CTO is applicable only to non-teaching/administrative personnel.

In this regard, may we request that DepEd personnel, both teaching and non-teaching, who are willing to participate in any or all of these activities, be allowed to join these activities on Official Time and that, in participating, they will be granted CTO or service credits, whichever is applicable.
