
### GUIDELINES AND CRITERIA FOR THE VIGAN CITY URBAN LEGEND WRITING:

- 1. The activity is open to all bona fide Biguenos aged 18 and above with good writing skills in English, Pilipino, or Ilocano.
- 2. The story shall have an exposition (introducing the world and characters), an inciting incident, rising action (building towards conflict or climax), climax, and falling action/the denouement, and shall only consist of a maximum of 1,500 words.
- 3. The story must be known or popular, either in the writer's street, purok, barangay, or in the city of Vigan, and it must be connected with the city's rich culture, traditions, beliefs, and history, such as the old structures, locations, and/or events.
  - 4. The setting and characters, especially the antagonist, must be described.
  - 5. The story must be submitted on or before August 16, 2024, spo@vigancity.gov.ph.
  - 6. The submission shall be an automatic waiver of Intellectual Property rights over the work and the City Government of Vigan reserves the right to revise, publish and/or use the same for all purposes it may deem fit.
  - 7. Only fifteen (15) best stories will be chosen by the City Government of Vigan based on the following criteria:
  - Creativity and Originality (25%) (How unique and imaginative is the legend or story? Does it offer a fresh perspective or twist on a familiar theme?)
  - Atmosphere and Setting (15%) (How effectively does the writing create a sense of place and mood? Does it evoke a spooky or eerie atmosphere appropriate to the theme?)
  - Plot and Structure (10%) (Is the story well-structured with a clear beginning, middle, and end? Are there elements of suspense or surprise that engage the reader?)
  - Language and Style (10%) (How skillfully is language used to enhance the spooky elements of the story? Is there a good balance of description, dialogue, and narrative
  - Adherence to Theme (25%) (Does the story effectively explore the urban legend or spooky theme related to Vigan City? Is there a connection to local folklore or history?)
  - Impact and Engagement (10%) (How compelling and memorable is the story? Does it leave a lasting impression on the reader?)
  - Overall Quality (5%) (Considering all the above criteria, how well-crafted is the story in terms of literary merit and entertainment value?)
  - 8. A simple token of recognition will be given to the 15 chosen stories on August 30, 2024, at 6:00 PM at Plaza Burgos, Vigan City.

#### GUIDELINES AND CRITERIA FOR THE VIGAN CITY TRUE TO LIFE SPOOKY STORY WRITING:

- 1. The competition is open to all interested individuals aged 18 and above with good writing skills in English, Pilipino, or Ilocano.
- 2. The participant shall either a resident or a tourist in the city of Vigan who has personally witnessed a spooky, disturbing or ghostly encounter in the heritage city.
- 3. The story shall have an exposition (introducing the world and characters), an inciting incident, rising action (building towards conflict or climax), climax, and falling action/the denouement, and shall only consist of a maximum of 1,500 words.
- 4. It must be connected with the city's rich culture, traditions, beliefs, and / or history, such as the old structures, locations, and/or events.
- 5. Supporting documents such as images, videos, audio recordings, and other documents are encouraged.
- 6. The setting and characters, especially the antagonist, must be thoroughly described.
- 7. The story must be submitted on or before August 16, 2024, at spo@vigancity.gov.ph.
- 8. The submission shall be an automatic waiver of Intellectual Property rights over the work and the City Government of Vigan reserves the right to revise, publish and/or use the same for all purposes it may deem fit.
- 9. Only fifteen (15) best stories will be chosen by the City Government of Vigan based on the following criteria:
- Originality and Authenticity (25%) (How unique and true is the story. Does it offer a fresh perspective or twist on familiar theme.)
- Atmosphere and Setting (15%) (How effectively does the writing create a sense of place and mood. Does it evoke a spooky or eerie atmosphere appropriate to the theme)
- Plot and Structure (10%) (Is the story well-structured with a clear beginning, middle, and end. Are there elements of suspense or surprise that engage the
- Language and Style (10%) (How skillfully is language used to enhance the spooky elements of the story. Is there a good balance of description, dialogue, and narrative flow.)
- Adherence to Theme (25%) (Does the story effectively explore the spooky theme related to Vigan City. Is there a connection to local folklore or history.)
- Impact and Engagement (10%) (How compelling and memorable is the story. Does it leave a lasting impression on the reader.)
- Overall Quality (5%) (Considering all the above criteria, how well-crafted is the story in terms of literary merit and entertainment value.)
- 10. A simple token of recognition will be given to the 15 chosen stories on August 30, 2024, at 6:00 PM at Plaza Burgos, Vigan City.
