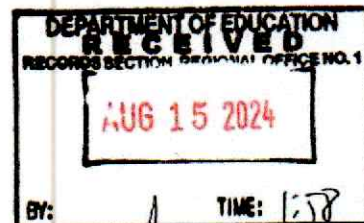

In furtherance of DepEd Order No. 31, s. 2022 titled "Adopting the Rights-Based Education (RBE) Framework for Philippine Basic Education," which embodied DepEd's strong resolve to respect, protect, fulfill, and promote the rights of all children in basic education, this Memorandum is issued for the dissemination of the Teaching Manual on Children's Rights in all private schools.
