
SUBJECT: 40TH PROVINCIAL COUNCIL SCOUT JAMBOREE (PCSJ)

1. The Boy Scouts of the Philippines, Ilocos Sur Council is pleased to announce the conduct of the **40TH PROVINCIAL COUNCIL SCOUT JAMBOREE (PCSJ) on November 07 to 10, 2024 at Libtong, Tagudin, Ilocos Sur** with a theme: **"Futureproofing Scouting for the Next Century and Beyond"**. **Pre Jamboree of all District and Secondary Coordinators on November 06, 2024 at the campsite.**
2. Jamborees or scouting events are always part of the school curriculum. While there are limitations mandated by the DepEd at the time on tasks, the DepEd family finds time to integrate conduct of institutional camp & district camps. Conduct of such kind of activities is always looked forward by young people who are members of the organization.
3. This Jamboree aims to provide a progressive, safe and enjoyable learning environment for the Scouts in order to enhance their physical, social, mental, emotional and spiritual potentials. At the end of the Jamboree, the participants should be able to:
 - Develop core values, life skills, leadership capabilities through the activities of World Scout Environment Education Program,
 - Undergo activities that will cater the completion of requirements of selected merit badges and scout rank.
 - Keep their selves abreast with the prevailing issues about environment through team buildings, group dynamics and decision making.
4. Jamboree participation is open to all currently registered members of the Boy Scouts of the Philippines who are physically fit to undergo strenuous activities with camping experience and leadership potentials.

5. Every contingent must be equipped with adequate camping gears and equipment (Scout Uniform, food supplies, cooking gears, water containers, sleeping gears, tent, medicine kit, extension wire & bulbs, etc.)
6. A **registration fee of Php 350.00** per boy/senior and **Php 350.00** per unit leader shall be charged to cover expenses for program materials, certificates, administrative costs and other operating expenses. **Registration Fees may be paid in advance** at the Council Office on or before November 01, 2024 upon organizing their contingents.
7. Scout Leaders who shall participate/serve/facilitate are advised to register in their respective section per school/district or secondary school to avail service credits grant. Every district and secondary school is expected to promote participation in this annual scouting event.
8. Enclosed are the Participants Application Form with Parent's Permit as required for every scout.
9. For strong support, immediate and widest dissemination and compliance of all concerned.
