All BAC Members, BAC-TWG, Observers, End-users and Prospective Bidders are hereby informed that the Opening of Bids for the above project originally scheduled on **November 11**, **2024**, **1:00 p.m.** is hereby postponed in response to Executive Order No. 33, s. 2024, issued by the Provincial Government of Ilocos Sur. An order declaring the suspension of classes in all levels of public and private schools, as well as work in public offices in the Province of Ilocos Sur on 11 November 2024 as a safety measure, and in order to prepare for and minimize the adverse effects and damages of severe tropical storm "Nika". Furthermore, the Philippine Atmospheric, Geophysical, and Astronomical Services Administration (PAGASA) has issued Tropical Cyclone Bulletin No. 12, declaring Tropical Cyclone Wind Signal no. 4 in the Province of Ilocos Sur, which also necessitates the rescheduling of the bid opening for the safety and convenience of all participants.

Relevantly, under Section 29. Bid Opening of the 2016 Revised Implementing Rules of R.A. 9184, "In case the bids cannot be opened as scheduled due to justifiable reasons, the BAC shall take custody of the bids submitted and reschedule the opening of bids on the next working day or the soonest possible time through the issuance of Notice of Postponement to be posted in the PhilGEPS website and the website of the procuring entity concerned."


