  - e. Proof of attendance in the Comprehensive Examination (post-exam, as needed)
- School Heads of the concerned teacher-scholars shall make necessary arrangements to ensure that No Disruption of Classes Policy will be strictly observed. Likewise, Head of Office of concerned school head/supervisor-scholars shall ensure that office operations and efficiency will not be hampered in the provision of support and consideration.
