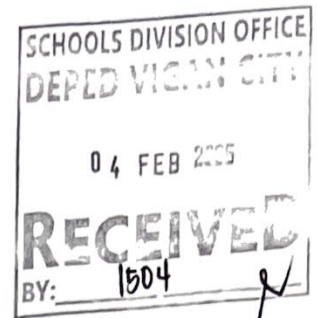

**SUBJECT: 2025 DISTRICT SCOUTING COMMITTEE REORGANIZATION AND ELECTION OF OFFICERS**

1. The standard Local Council Constitution and Bylaws of the Boy Scouts of the Philippines (BSP) provides that the Local Council territory shall be divided geographically into Scouting Districts, where District shall have an organized and functional District/Municipal Scouting Committee.

3. The District Scouting Committee must conduct their elections within February 2025 as mandated. The different District Chairman and District Commissioners concerned shall make arrangements for the attendance of institutional heads, Lay Leaders, and Unit Leaders in their respective jurisdiction to effect the reorganization of the District Scouting Committees for 2025.
