Division Orientation on the Adolescent Reproductive Health Program

To: Assistant Schools Division Superintendent
Chief Education Supervisor (CID and SGOD)
Public Elementary and Secondary Schools Heads
All Others Concerned

1. The DepEd's mandate under the *Responsible Parenthood and Reproductive (RPRH) Health Law of 2012* or the Republic Act No. 10352 and the DepEd Order No. 31 s. 2018, also known as "*Policy and Guidelines on Comprehensive Sexuality Education*", seeks to advocate adolescent reproductive health and adolescent reproductive health related activities at schools and offices for learners and personnel.
2. In line with this, the Schools Division of Vigan City through the School Governance Operations Division under School Health and Nutrition Section shall conduct the *Division Orientation on Adolescent Reproductive Health Program* with the theme: "**Empowering Youth, Igniting Change**" at Westloch Park Hotel, Sto Domingo, Ilocos Sur on February 17, 2025.
3. The activity aims to:
 - a. To orient and train the adolescent reproductive health coordinators, registered guidance counselors, guidance counselor designate, mental health coordinator and school nurses on the screening tool to assess the physical, mental and social well-being of adolescents allowing early identification of risk and provision of intervention.
 - b. To orient employees about various adolescent reproductive health challenges and issues and how to approach and handle adolescents with pressing problems related to Adolescent Reproductive Health.
 - c. To empower and capacitate learners with knowledge on how to deal with their issues and how to prevent or avoid succumbing to risky behaviors.
4. The participants in this activity include the learners from the 21 public elementary and secondary schools, school guidance designates, school adolescent health coordinators, ALS learners and ALS teacher. Attached is the list of participants and the members of the Program Management Team.




