### PARTICIPATION TO THE 2025 REGIONAL FESTIVAL OF TALENTS (RFOT)

- Per DepEd Regional Memorandum No. 145, s. 2025, the Department of Education Regional Office I through the Curriculum and Learning Management Division (CLMD), shall conduct the 2025 Regional Festival of Talents (RFOT) with the theme "Empowering Filipino Youth: Unleashing Potentilas in Creative Industries in the Era of AI" at the Schools Division of Dagupan City, Dagupan City, Pangasinan on February 11-12, 2025 (exclusive of travel time).
- 2. The RFOT is an annual co-curricular activity of DepEd ROI that provides meaningful learning opportunities for basic education learners to display their talents and skills anchored on the learning competencies achieved in schools. It serves as a culminating activity that gauges learning mastery and skill development in accordance with learning standards.
- 3. Enclosed is the list of contestants in the different events, delegation officials, and general instructions to RFOT delegates.

- 5. There shall be **no registration fee** for the 2025 RFOT. Materials needed for the event exhibition, travel expenses, meals and other incidental expenses of learner-participants, teacher-coaches, and other official delegates shall be charged to their School MOOE/Local funds or other eligible funds sources, subject to the usual government accounting and auditing rules and regulations.
- 6. Learner-participants are required to secure parent's consent (see Annex 1) to be collected by their respective coaches and submit it to the EPS concerned on or before February 7, 2025. Coaches shall ensure the safety, health and well-being of their contestants throughout the activity.




