





5. Participants must wear appropriate sports attire and bring necessary sports paraphernalia for the practicum sessions during the accreditation process.
6. School heads are requested to assign alternate teachers to handle the affected classes in accordance with DepEd Order No. 9, s. 2005 titled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance.
