The regional winners will advance to the next and final level of the competition level during the National Invention Contest and Exhibits (NICE) which will be held in 2026.

This biennial regional invention contest provides a venue to sustain the generation of economically viable technologies and inventions and hasten the commercialization of inventor-generated technologies. In this regard, we hope for your **assistance in disseminating this activity to your network of schools, to join and participate in the said regional invention contest**. The participation is free of charge, however, certain rules and criteria should be followed.
