2. In order to protect personnel and prevent the occurrence of a scam or when any personnel offer high or fantastic earnings on your investment, this office informs everyone to report to the Legal Officer in the Schools Division Office thru the following channels:

 - b. Via SMS/Viber: 0917-832-9007 (9:00-5:00, Mon-Fri)
 - c. Personal appearance at the Schools Division Office
3. Personnel who come across any investment offer by phone, e-mail, flyers, newspaper ads, or directly by any person, or by any other means, the following information must be obtained:
 - a. Name of the person and the company making the offer;
 - b. Address of both the person and the company;
 - c. Phone number, particularly the landline. Do not accept cellular phone numbers as the owner cannot be traced;
 - d. Obtain SEC Registration or appropriate license to engage in activities; and
 - e. Check and verify the name of the company from the list of companies who offer investments as posted on the SEC Website.
4. For widest dissemination, information, guidance, and strict compliance.

DEPED REGION 1 PERSONNEL TO ANY INVESTMENT**

To: All Schools Division Superintendents

1. This Office received reports on the involvement of DepEd Region 1 personnel, teaching, non-teaching, teaching-related personnel, who participate and engage in companies who offer investments without further verifying the presence of appropriate license to engage in such activities.

2. To give awareness and information to all personnel, this Office issues this advisory to protect personnel and prevent the occurrence of a scam.

3. Personnel who come across any investment offer by phone, e-mail, flyers, newspaper ads, or directly by any person, or by any other means, the following information must be obtained:

- a. Name of the person and the company making the offer.
- b. Address of both the person and the company.
- c. Phone number, particularly the landline. Do not accept cellular phone number (s)- the owner cannot be traced.
- d. Obtain SEC Registration or appropriate license to engage in activities.
- e. Check and verify the name of the company from the list of companies who offer investments as posted on the SEC Website.

4. In case any personnel offer high or fantastic earnings on your investment, kindly refer the matter to any Legal Officer in the Schools Division Office or in the Regional Office for appropriate legal advice.
