


These individuals are expected to report to their respective training venues on the date indicated in the BSP letter for orientation and preparation prior to the start of the training activities.



- 4. As embodied in DepEd Unnumbered Memorandum dated 14 April 2025, all participants who signified participation in these training courses of Advanced Training Courses shall coordinate with their respective school heads on their desire to avail their declared 30day vacation leave.
- 5. Council Scout Executives are enjoined to assist their participants in seeking support for the payment of their registration from their local government using the joint DBM, DepEd and DILG Joint Memorandum No. 1 & 2 series 2020 and DILG Memorandum No. 11 series 2018.
- 6. Other matters relevant to the conduct of these training courses will be issued from time to time.
