

- 2. Trainers who are in the process of completing the requirements for the issuance of their honorable charge as Leader Trainers or in taking the Course for Managers of Training are given priority to serve; however, in case their local council fails to send the required number of quota for participation, the slots will be given to the other councils. These trainers are requested to recruit participants to ensure their assistance in the training courses.
- 3. Payment/deposit made is non-refundable but transferable to other unit leaders. Should we fail the to complement the required 32 participants (better management the course) in a course, it is only the time that we will return the reservation fee.

- 4. As embodied in DepEd Unnumbered Memorandum dated 14 April 2025, all participants who signified participation in these training courses of Advanced Training Courses shall coordinate with their respective school heads on their desire to avail their declared 30day vacation leave.
- Council Scout Executives are enjoined to assist their participants in seeking support for the payment of their registration from their local government using the joint DBM, DepEd and DILG Joint Memorandum No. 1 & 2 series 2020 and DILG Memorandum No. 11 series 2018.
- 6. Other matters relevant to the conduct of these training courses will be issued from time to time.
- 7. All concerned are enjoined to disseminate and give attention to this memorandum to especially those who failed to complement the number of qualified staff in the conduct of their unit leaders basic training courses.
