- 1. In reference to DepEd Memo No. 22 s. 2015 or The Annual Physical Exam of DepEd employees (Teaching and Non-Teaching personnel), DepEd Order no. 44, s. 2004 re: Strengthening DepEd's TB prevention and Control Program through Adoption of the Comprehensive and Unified Policy on TB Control Program in the Philippines (CUPTBCP) and Civil Service Memorandum Circular No. 17 s. 1989 (Physical and Mental Fitness for Continued Employment in the Public Service, all Non-teaching and Teaching personnel are required to undergo Annual Physical Examination (APE).
- 2. The APE aims to ensure that all employees are physically fit to perform their assigned duties and responsibilities.
- 3. The following diagnostic tests are recommended (whichever is applicable):

- This memorandum serves as Laboratory and Diagnostic Request to be presented at the laboratory/hospital of choice of the employee.
- Annual Physical Examination (APE) for SDO personnel shall be done at the SDO - Clinic from May 26, 2025- May 28, 2025. APE for school-based personnel shall be done starting July 7, 2025 onwards in their respective schools. Laboratory and diagnostic results will be presented to the Medical Officer during your scheduled APE. Personnel with existing comorbidities are strongly advised to have their regular check-up and follow up with their attending physicians.
- 6. Laboratory tests must be accomplished according to their prescribed period of validity. To wit:
 - a. Chest Xray PA View not earlier than 6 months prior to physical examination
 - b. Blood Chemistry not earlier than 3 months prior to physical examination
 - c. Complete Blood Count not earlier than 1 week prior to physical examination
 - d. Urinalysis not earlier than 1 week prior to physical examination
- Schools are instructed to prepare the following forms to be used during the 7. APE:
 - a. SHD Form 4 Teacher's Health card and Health Examination Record
 - b. SHD Form 1c Medical Treatment Record


