**CAREER GUIDANCE PROGRAM SCHOOL-BASED TRAINING
OF CAREER ADVOCATES**

1. Pursuant to Republic Act No. 10533, or the "Enhanced Basic Education Act of 2013," the Department of Education (DepEd) reaffirms its commitment to building a responsive and effective basic education system that fosters productive and responsible citizens. The Schools Division of Vigan City will conduct a school-based training for career advocates from September 16 to 19, 2025. The venue will be announced in a separate memorandum.
2. The training program is aimed at helping participants:
 - a) Analyze the current implementation of the Career Guidance Program in basic education, identify existing gaps and challenges, and recommend school-specific strategies for improvement and sustainability;
 - b) Demonstrate a clear understanding of the key theories, principles, and goals of guidance as a vital support system that enhances learner development and strengthens the teaching-learning process;
 - c) Explain the role and framework of Career Advocacy within DepEd's Career Guidance Program, and effectively use available tools, resources, and learner profiling data to support students in making informed, meaningful academic and career decisions;
 - d) Employ effective instructional strategies and make purposeful use of career development materials to guide secondary school learners in becoming career-aware, goal-oriented, and equipped for future academic and employment pathways; and
 - e) Complete a summative assessment to demonstrate the knowledge, skills, and competencies acquired from the training, as a requirement for certification as a Career Advocate.
