MENTAL HEALTH TRAINING FOR STUDENT LEADERS "VOICES OF WELLNESS: LEADING CHANGE FOR MENTAL HEALTH"

- To: Assistant Schools Division Superintendent Chief Education Supervisor (SGOD & CID) Public and Private Elementary and Secondary School Heads All Others Concerned
- 1. Pursuant to Department of Education's Memorandum No. 003, s. 2021 or the "Mental Health and Psychosocial Support Services (MHPSS) Framework," which mandates the integration of mental health education in schools, the Schools Division of Vigan City will conduct Mental Health Training for Student Leaders with the theme "Voices of Wellness: Leading Change for Mental Health" at Max's Vigan City on October 8-9, 2025.
- 2. The training program is aimed at helping participants to:
 - a) define Mental Health and explain the different perspectives in Mental Health to the participants;
 - b) capacitate the participants in the national and international laws governing mental health;
 - c) imbibe the three thrusts of mental health: Promote, Prevent, Preserve;
 - d) dispel misconceptions about Mental Health and identify factors affecting mental health and explore ways of improving one's mental health;
 - e) capacitate the participants in identifying common mental health disorders and causes for the participants to develop effective ways of protecting oneself from developing serious mental health problems;
 - f) develop skills in conducting basic psychological first aid and facilitating individuals with indicators or living with mental health problems; and
 - g) help participants gain self-awareness, confront personal issues and concerns, develop personal development plan and develop skills in self-help and helping others
- 3. Enclosed are the program matrix, the composition of the program management teams, and the list of identified participants.
- 4. Furthermore, schools of identified student leaders are requested to submit name of participating teacher-adviser (1 per school) to be submitted to this office not later than **September 19,2025.**


