

### LIP SYNC BATTLE FULL PRODUCTION GUIDELINES AND MECHANICS

#### General Guidelines

- 1. The competition is open to all public schools in Vigan City offering basic education.
- 2. There shall be nine (9) competing team, distributed as follows:
  - 2 teams per Cluster
  - 1 team per public secondary schools
- 3. Each team shall have a minimum of three (3) and a maximum of five (5) members, composed of both male and female performers or all males/females.
- 4. Performances should not include foul language, explicit acts, or any form of indecency.
- 5. Participants must impersonate a well-known local or international artist or group (can be Hollywood, Filipino, K-Pop) and perform one full song of their chosen act.
- 6. Music should be submitted in CD or USB format. Remix versions are not allowed. The team leader must provide a back-up copy to prevent technical
- 7. Each group is required to prepare a one-minute introduction video or presentation showcasing their chosen local or international artist or group (can be Hollywood, Filipino, K-Pop) prior to their performance.
- 8. All performers shall also participate in a production number to be staged as part of the opening and/or closing program.
- 9. The actual performance should run for a minimum of 3 minutes and a maximum of 6 minutes, inclusive of entrance and exit.
  - · Timing will officially begin only after the one-minute introduction video and the first movement of the participants.
  - Time violations: One (1) point will be deducted from each judge's raw score per minute of overtime or undertime. Fractions of a minute will also incur deductions.
- 10. Props are allowed to enhance the performance, but fireworks, firecrackers, and similar hazardous items are strictly prohibited.

#### Criteria for Judging

- Lip-Sync Performance
  - (Accuracy in syncing the lyrics of the song) 40%
- Style and Creativity
  - (Originality, props, choreography, costumes, overall concept, and crowd impact) - 25%
- Stage Presence & Choreography
  - (Audience engagement, confidence, eye contact, facial expressions, and energy) - 25%
