Vacation Service Credits for Voluntary Participation in Professional Development Activities During the Midyear Break

- This Office disseminates the enclosed Memorandum DM-OUHROD-2025-2949, dated October 23, 2025, from Undersecretary Wilfredo E. Cabral regarding the granting of Vacation Service Credits (VSC) for voluntary participation in professional development activities during the Midyear Break from October 27 - 30, 2025
- 2. Key provisions from the memorandum are as follows:
 - Teachers who voluntarily attend these activities shall be granted 1.5 days
 VSC per eight (8) hours of rendered services.
 - This grant is **inclusive** of the maximum limitation specified under DepEd Order 13, s. 2024.
 - The activities must be **pre-approved** and conducted by the Central Office, Regional Office, or Schools Division Offices (SDO).
 - Eligible activities include training, professional development, planning or policy workshops, output-based activities like writeshops, and other approved activities aligned with DepEd's goals.
- 3. All concerned, especially School Heads, are enjoined to ensure **proper** documentation and submission of attendance and activity reports to facilitate the prompt processing of VSCs.
- 4. For immediate and wide dissemination to all teaching personnel.




In line with the declaration of the Midyear Break from October 27 to 30, 2025 as a Wellness Break for teachers, and in recognition of the commitment of teaching personnel to continuous professional growth and development, Vacation Service Credits (VSC) shall be granted to teachers who voluntarily participate in pre-procured and pre-planned professional development programs as well as other DepEd activities during the said period.

Teachers who attend these activities voluntarily shall be granted 1.5 days VSC per eight (8) hours of rendered services, inclusive of the maximum limitation under DepEd Order 13, s. 2024, provided that the activities are pre-approved activities conducted by the Central Office, Regional Office, or Schools Division Offices (SDO). These activities may include training or professional development, planning or policy workshops, output-based activities such as writeshops, and other such approved activities that teachers were requested to attend and which are aligned with the Department's strategic initiatives or professional development goals.

This aims to acknowledge the dedication of teachers who choose to engage in professional development during their break and ensures that their efforts are duly compensated. All concerned are enjoined to ensure proper documentation and









submission of attendance and activity reports to facilitate the granting and processing of VSCs.

VACATION SERVICE CREDITS FOR VOLUNTARY PARTICIPATION IN PROFESSIONAL DEVELOPMENT ACTIVITIES DURING THE MIDYEAR BREAK

To: Schools Division Superintendents All Concerned Personnel

- 1. In reference to Regional Memorandum No. 1436, s. 2025 titled Declaration of Midyear Break as Wellness Break and Guidelines for Professional Development Activities, teachers may be granted Vacation Service Credits (VSC) if they voluntarily participate in pre-procured and pre-planned professional development programs or other DepEd activities during the said period.
- 2. Teachers who attend these activities voluntarily shall be granted 1.5 days VSC per eight (8) hours of rendered services, inclusive of the maximum limitation under DepEd Order 13, s. 2024, provided that the activities are pre-approved activities conducted by the Central Office (CO), Regional Office (RO), or Schools Division Offices (SDOs). These activities may include training or professional development, planning or policy workshops, output-based activities such as write shops, and other such approved activities that teachers were requested to attend, and which are aligned with the Department's strategic initiatives or professional development goals.
- 3. Participation of teachers during the Midyear Break shall remain purely voluntary. The requirement for submission of reports by SDOs to RO and schools to SDOs is intended solely for monitoring purposes and to maintain a record of voluntary participation, especially in cases where the planned activity can no longer be rescheduled. No teacher shall be required or compelled to participate in any activity during the declared Wellness Break period.
- 4. This issuance recognizes and appreciates the commitment of teachers who choose to use their Midyear Break productively while ensuring that their rendered services are properly documented and credited. All concerned are advised to ensure proper reporting and verification of attendance to facilitate the processing of corresponding VSCs.
