CONDUCT OF VIGAN CITY ATHLETIC MEET 2025-2026

To: Assistant Schools Division Superintendent
Chief Education Supervisor (SGOD & CID)
Public and Private Elementary, Secondary School Heads and SUC
All Others Concerned

- 1. The 1987 Philippine Constitution under Article XIV, Section 19, provides that the state shall promote physical education and encourages sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, excellence for the development of a healthy and alert citizenry; and that all educational institution shall undertake regular sports activities throughout the country in cooperation with athletic clubs and other sectors.
- 2. Furthermore, the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 10588 otherwise known as the Palarong Pambansa Act encourages the conduct of athletic meets in the District, Division, and Regional Level.
- 3. In line with these mandates, the Schools Division of Vigan City will hold a three-day City Athletic Meet with the theme "Dare. Dream. Rise to the Challenge" on November 11 & 14-15, 2025. The activity seeks to create avenues for young athletes to showcase their talents, pursue athletic excellence, and experience the value of teamwork and perseverance. It likewise provides an important opportunity for honing their competitive skills in preparation for higher levels of competition at the Regional and National Sports Meets.
- 4. The said sports event aims to:
 - a. promote physical education and sports as integral part of the basic education for holistic development of the youth to become responsible and globally competitive citizens in the community;
 - b. strengthen the spirit of sportsmanship, camaraderie, cooperation, perseverance and determination among learner-athletes and teacher-coaches:
 - c. provide opportunity to evaluate the sports management for the improvement of the teacher-coaches and officiating officials to sustainable development; and
 - d. select best learner-athletes for higher sports meet.
- 5. Participants to the activity are the athletes, coaches, assistant coaches, tournament & assistant tournament managers, officiating officials, members of the working committee, members of the monitoring team, Division Sports Executive committee and Technical Working Group.

RULES AND GUIDELINES ON THE ELIGIBILITY OF ATHLETES OF THE SDO VIGAN CITY MEET FOR SY 2025-2026

1. Participants

Participants in the Vigan City Meet for SY 2025-2026 are Elementary and Secondary learners from the public, private and laboratory schools who have participated in the school intramurals/meets.

2. Eligibility of Athletes

- a. Must be a Filipino citizen.
- b. Must be enrolled in a recognized school at the beginning of the current school year.
- c. Should have participated in the preliminary meets.
- d. Cut-off date for the age of elementary athletes is January 1, 2013 and the cut-off date for secondary athletes is January 1, 2008.
- e. Learner-athletes who transferred from one division to another within the region are allowed to participate, provided, they have participated in the lower meets.
- f. Elementary athletes shall play in the elementary division and secondary athletes shall play in the secondary division.

3. Disqualification

- a. Over age athletes.
- b. Athletes with failing grades in more than two (2) subjects in the previous grading.
- c. Athletes who are members of the National team, national training pool and development pool receiving monthly stipend/allowances from the PSC.
- d. Failure to submit pertinent papers for evaluation on the specified time.
- e. Penalized with suspension on ban during the previous city meet.


4. Required Documents for Athletes

- a. Copy of birth certificate issued by Philippines Statistics Authority (PSA). Late registration may be accepted provided the same was issued one (1) year prior to current city meet.
- b. Photocopy of SF10 duly signed by coach/teacher-adviser/registrar and certified correct by the school principal (signature over printed name).
- c. Medical and Dental certificates signed by a physician that athlete is physically fit and within the age limit require with validity of six (6) months from date of issue.
- d. Parent's/Guardian's consent.
