

I hope this message finds you well. I am writing to humbly ask for your kind support and financial assistance as my family is going through a very difficult time.

My mother, **Herminia D. Andres**, has been diagnosed with a **Brain Metastasis secondary to melanoma (which grew on her lungs)**. She underwent **Posterior Fossa Surgery** to remove a lesion in her brain, which costs around **P1,200,000.00 on Oct. 31, 2025** and **Gamma Knife Treatment Procedure** amounting to **P573,000.00 on Nov. 25, 2025**. She will be undergoing **Immunotherapy every 3 weeks for 2 years** amounting to **Php400,000.00 gross of 65% discount**.

We are doing our best to cover her medical expenses, but the cost of treatment is more than what we can afford. We are reaching out with hope that others may be willing to help us. **Any amount of support you can give would mean so much to us and would greatly help in her treatment and recovery.**
