



The Regional Office through the Curriculum and Learning Management Division-Learning Resource Management Section will be conducting a survey on the implementation of the Learning Resource Management and Development System (LRMDS), Region I Learning Resource Information System (RI-LRIS), and Utilization of Learning Resources from January 21-23, 2026.
2. The survey intends to:
  - a. gather information on the implementation of the LRMDS;
  - b. measure how well resources reach schools, teachers and learners across divisions;
  - c. gauge the impact on teaching and learning outcomes, including resource utilization, teacher proficiency, and alignment with curriculum needs;
