**IMPLEMENTATION OF SCHOOL ORGANIZATIONAL DIAGNOSIS THROUGH THE CONDUCT OF THE SBM LEADERSHIP TRAINING NEEDS SURVEY**

To: Schools Division Superintendent

School Heads of Public Elementary, Secondary and Integrated Schools  
All Others Concerned

1. In reference to Regional Memorandum No. 119, s. 2026, and DepEd Memorandum DM-OUHROD-2026-0149 dated January 23, 2026, titled *“Implementation of School Organizational Diagnosis through the Conduct of the SBM Leadership Training Needs Survey,”* all public school heads are hereby directed to participate in and ensure the conduct of the said survey.
2. The SBM Leadership Training Needs Survey aims to assess the leadership and organizational development needs of school heads in support of the effective implementation of the Revised School-Based Management (SBM) System, pursuant to DepEd Order No. 007, s. 2024. It further seeks to gather grassroots-level data on leadership training needs as part of the organizational diagnosis, identify priority areas, determine the scope of needs, and establish a structured framework for SBM leadership capacity-building programs.
3. In line with this, all public school heads (Elementary, Secondary, and Integrated Schools) are required to accomplish the survey through the Google Form link: [tinyurl.com/SBMFY26-SurveyForm](https://tinyurl.com/SBMFY26-SurveyForm).
4. For the orderly administration of the survey, the following guidelines shall be observed:
  - a. **Deadline** – The survey is available effective immediately and shall be completed not later than **February 9, 2026**.
  - b. **Submission** – Each school head shall submit only **one (1)** survey response. School heads handling multiple schools are still required to submit only one response.
  - c. **Email Account** – Respondents are strongly encouraged to use their official **DepEd email address** (personal or school-based).
  - d. **Data Accuracy** – Respondents must ensure that all basic school information and data provided are accurate and complete prior to submission, as multiple submissions are strictly prohibited.



The Department of Education (DepEd) issued DepEd Order No. 007, s. 2024, or the Policy Guidelines on the Implementation of the Revised School-Based Management (SBM) System, which emphasize foundational principles designed to guide and support the daily operations of public schools, ensuring alignment with the intended framework for school governance and management.
2. Relative to this, the Office of the Undersecretary for Human Resource and Organizational Development and Infrastructure issued Memorandum DM-OUHROD-2026-0149 to gather grassroots-level information on the leadership training needs of school heads as part of its organizational diagnosis. This initiative enables the Department to comprehensively identify the scope of needs, prioritize training interventions, and establish a structured framework for capacity-building programs tailored to SBM leadership.




The Department of Education (DepEd) recognizes the critical role of competent school heads in fostering effective and high-performing public schools. As primary leaders of their respective institutions, school heads are entrusted with various responsibilities that require continuous enhancement and development of their leadership competencies.

With the official issuance of **DepEd Order No. 007, s. 2024**, or the *Policy Guidelines on the Implementation of the Revised School-based Management (SBM) System*, the Department has provided an opportunity for a simplified and strengthened understanding and application of SBM. The abovementioned policy emphasizes foundational principles designed to guide and support the daily operations of public schools, ensuring alignment with the intended framework for school governance and management.

Through the lens of organizational development, the Office of the Undersecretary for

aims to gather grassroots-level information on the leadership training needs of school heads as part of its organizational diagnosis. This initiative shall allow the Department to comprehensively identify the scope of needs, prioritize training interventions, and establish a structured framework for capacity-building programs tailored to SBM leadership.

To advance this objective, the Bureau of Human Resource and Organizational Development – School Effectiveness Division (BHRD-SED) shall conduct the SBM Leadership Training Needs Survey effective upon issuance of this Memorandum until February 9, 2026.

The guidelines to ensure the proper and orderly administration of the survey are as follows:

1. The FTAD and SGOD shall ensure the proper dissemination of this Memorandum.
2. The Google Survey Form can be accessed at [tinyurl.com/SBMIX26SurveyForm](https://tinyurl.com/SBMIX26SurveyForm).
3. The school head is tasked to complete the survey. In cases where a school head oversees more than one public school, only one survey form must be submitted.
4. The respondent must ensure that all basic school information provided in the survey is accurate and complete.
5. Multiple submissions are not allowed. Respondents are expected to carefully review their answers before submitting the survey form.
6. If possible, only DepEd email addresses (personal and school accounts) should be used and declared for this purpose.
