This Memorandum provides guidance on the conduct of the **end-of-the-school-year (EOSY) assessments** nationwide for the School Year (SY) 2025-2026.

The Comprehensive Rapid Literacy Assessments (CRLA), the Philippine Informal Reading Inventory (Phil-IRI), and the Rapid Mathematics Assessment (RMA) shall be administered to all **Grades 1 to 10 learners** from **February 18 to March 18, 2026**.

Regional Offices and Schools Division Offices are requested to designate a representative who can provide technical assistance to schools requiring support in administering assessments and submitting assessment data. A separate advisory shall be issued for this purpose.

All schools are required to encode the results of these assessments after the completion of the EOSY assessments through the submission link: <https://bld.deped.gov.ph/submit>, not later than March 20, 2026.
