**DIVISION TRAINING-WORKSHOP ON ASSESSING STUDENTS' ACHIEVEMENT
 OF K TO 12 LEARNING AREAS' STANDARDS AND COMPETENCIES**

1. The Schools Division of Vigan City through the Curriculum Implementation Division shall conduct the Division Training-Workshop on Assessing Students' Achievement of K to 12 Learning Areas' Standards and Competencies on **May 28-30, 2026**. The venue will be announced in a separate memorandum.
2. The training-workshop aims to:
 - a. Unpack the alignment of learning targets of standards and competencies with assessment methods using the classroom assessment matrix;
 - b. Discuss the general characteristics of valid standards-based assessments;
 - c. Compare traditional assessment style with international large-scale assessments (e.g. Programme for International Student Assessment or PISA);
 - d. Critique and revise current samples of selected response test items, constructed response test items and performance tasks with a given guide;
 - e. Critique and revise current tables of specifications;
 - f. Present revised unit tables of specifications, selected and constructed response test items and performance tasks designs for critiquing; and
 - g. Identify next steps for assessing student learning.
3. The participants to this activity are the Program Management Team, Education Program Supervisors, School Heads, Asst. Principal, Department Heads, Subject Group Heads and selected Master Teachers/Key Teachers.
4. The participants are advised to bring their writing materials, laptop, extension wire, pocket WiFi or other sources of internet connections in attending the said activity.
5. All participants involved in the activity shall bring copies of Table of Specifications (TOSs) and quarterly examinations in their learning area assignments.
6. Attendance of all identified participants is required.
