"MORAL RECOVERY AND SPIRITUAL ENHANCEMENT ORIENTATION"

A. What is the Moral Recovery Program?

- a. **Movement** - which aims to mobilize all Filipinos for nation building through the practical exercise of human values in our daily lives as citizens and to awaken us all to the power of these values in achieving our individual and national goals.
- b. **For All Filipinos** - In 1996, Executive Order No. 319 was issued by President Fidel V. Ramos calling for the institutionalization of the *Moral Recovery Program* in all government agencies, departments, and all government-owned and controlled corporations. Thus, the *Moral Recovery Program* became an official government policy, enjoining all government employees and everyone from all walks of life to participate in the national campaign for Moral Recovery.
- c. **Mandated** –
 - i. Presidential Proclamation #62 dated September 30, 1992 –Moral Recovery Program
 - ii. Executive Order #319 dated April 3, 1996
INSTITUTIONALIZING THE MORAL RECOVERY PROGRAM (MRP) IN ALL GOVERNMENT DEPARTMENTS
 - iii. Executive Order #713 Lecture and Seminar on Values Formation to LGUs' Barangays and Schools
 - iv. Republic Act #6713 to promote a high standard of ethics in public services. Public officials and employees shall at all times be accountable to the people
 - v. Executive Order #347 dated June 8, 2004, CREATING THE PRESIDENTIAL COMMISSION ON VALUES FORMATION
 - vi. Republic Act # 11467 dated July 22, 2019 -An Act known as GOOD MANNERS AND RIGHT CONDUCT and VALUES EDUCATION ACT

 - ✓ "One who maintains cleanliness keeps away diseases."
 - ✓ "Cleanliness is next to godliness."
