1. Pursuant to the approval and promulgation of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 10627, the Bureau of Learner Support Services – Learner Rights and Protection Division (BLSS-LRPD) shall conduct the **National Orientation and Consultation on the Revised Implementing Rules and Regulations of Republic Act No. 10627**, otherwise known as the **Anti-Bullying Act of 2013**, on **June 15–18, 2026** at Baguio Teachers' Camp, Cordillera Administrative Region.

2. The objectives of this training are to:

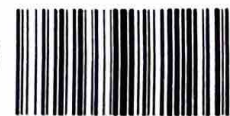
