1. In reference to **Regional Memorandum No. 699, s. 2026** titled, "*Reorientation Program for Teaching Personnel on the DepEd Order No. 49, s. 2026 or the Revised Rules of Procedures of DepEd in Administrative Cases and Other Related Issuances*", the Department of Education Regional Office I, through its Legal Unit, shall conduct the said activity at the National Educators Academy of the Philippines-Region I (NEAP-R1) on **June 25, 2026**.
