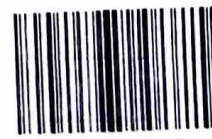

In line with the Department of Education's continuing efforts to ensure the clear, standardized, and consistent implementation of DepEd Order No. 012, s. 2026 on the *Government Recognition of Private Basic Education Institutions (PBEIs) offering the Senior High School (SHS) Program*, this Office will conduct an online pre-training for all designated Monitoring, Evaluation, and Inspection Team (MEIT) members from Regional Offices (ROs) and Schools Division Offices (SDOs).

1. The online pre-training shall be conducted with the following details:
 - Date: June 29, 2026 (Monday)
 - Time: 1:00 PM to 4:00 PM
 - Platform: MS Teams
2. The activity shall involve all representatives from ROs and SDOs who are designated or being considered for designation as MEIT members. Each office (e.g., RO NCR, SDO Manila, SDO Pasig) shall join the online pre-training using **one official DepEd account per office only**.
3. Only the designated office account shall accomplish this official pre-registration form: <https://tinyurl.com/Pre-RegMEITPT> on or before June 24, 2026 (Wednesday). Pre-registration is strictly required, and only DepEd accounts that have successfully completed pre-registration shall be admitted to the online pre-training.
4. The online meeting link is intended for official DepEd use only and must not, under any circumstances, be shared, forwarded, or disseminated to private schools, private school associations, or any external stakeholders.

MONITORING, EVALUATION, AND INSPECTION TEAM

- RD establishes the Monitoring, Evaluation and Inspection Team (MEIT) to evaluate applications
- The MEIT shall consist of three, five, or seven (3-5-7) members, including RO representatives and SDO representatives with jurisdiction over the applicant
- The RO and SDO must each have a representative in the MEIT
- MEIT members must complete DepEd RO training. Membership, roles, and functions shall be formalized through a Regional Memorandum, with copy furnished to PEO
