Transportation expenses incurred by participants who opt to use their private vehicles may be charged against local funds (School MOOE or SDO Operational Funds), subject to the availability of funds and compliance with existing government budgeting, accounting, auditing, and other applicable rules and regulations.

Since the activity will be conducted on a Friday, a **skeletal workforce** shall be maintained in the Schools Division Office and schools to ensure the uninterrupted delivery of frontline services and the continuous operations of the Office.
