LEARNER RIGHTS AND PROTECTION SPECIALIZATION COURSE

To: Schools Division Superintendents

1. Consistent with the Department of Education commitment to ensuring safe, inclusive, and child-friendly learning environments, this Office announces the conduct of the **Learner Rights and Protection (LRP) Specialization Course** on **August 23-27, 2026**.

2. The activity aims to strengthen the knowledge, skills, and competencies of school personnel in implementing learner rights and protection policies and programs, as well as enhancing school-based mechanisms for safeguarding learners.

3. To ensure appropriate representation, each Schools Division Office (SDO) is requested to identify and endorse the following participants from its respective division:

- One (1) School Head;
- One (1) Learner Rights and Protection (LRP) Advocates;
- One (1) Guidance Designate; and
- One (1) Guidance Counselor

As an exception, the Schools Division Office of Pangasinan I and La Union shall endorse five (5) participants, while the Schools Division Office of Pangasinan II shall endorse six (6) participants.

4. Each Schools Division Office (SDO) shall submit the names of its identified participants on or before **July 27, 2026**. The names submitted shall be considered the official registered participants and shall be reflected in the official registration form and attendance sheet of this Office.

5. Replacement, substitution, or proxy participants shall not be allowed. Accordingly, only those whose names have been officially submitted by the Schools Division Office and reflected in the official registration form and attendance sheet shall be recognized as participants in the activity.

7. Be guided accordingly.

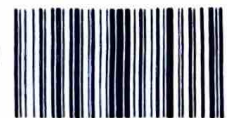
