**ORIENTATION ON LEARNING SYSTEMS REFORM POLICIES

1. In support of the effective implementation of recent Learning Systems Reform Policies, the Schools Division Office, through the Curriculum Implementation Division, shall conduct the **Orientation on Learning Systems Reform Policies and Related DepEd Issuances on August 20-21, 2026**. The venue shall be announced through a separate memorandum.

2. The activity aims to:

- a. orient instructional leaders, Administrative Officers, and teachers on the key provisions and implementation requirements of the Three-Term School Calendar, Learning Systems Reform Policies, and related DepEd issuances;
- b. discuss the salient provisions of DepEd Order Nos. 03, 009, 014, 015, 016, and 017, s. 2026 and their implications for school-level implementation;
- c. provide technical assistance in identifying implementation needs and preparing responsive Technical Assistance Plans, or Mentoring/Coaching Plans; and
- d. gather implementation issues, concerns, and feedback to guide monitoring, reporting, and follow-through technical assistance.

3. The participants in this activity are the School Heads, Department Heads, Subject Group Heads, and select Master Teachers. See attached schedule of participants per day. They are advised to bring laptop, extension wire and existing copies of the school Literacy and Numeracy Program and school Learning and Service Continuity Plan (LSCP)

4. Participants are expected to attend the activity for the entire duration and actively participate in the discussions, workshops, presentation of outputs, and clarification of implementation issues. School heads shall make the necessary arrangements to ensure that school operations are not disrupted.

5. Expenses for meals, snacks, venue, supplies, materials, and other authorized activity requirements shall be charged against OSEC-1-26-02774, subject to the usual government accounting and auditing rules and regulations.
