1. The Schools Division of Vigan City informs the field on the conduct of a Courtesy Meeting and Project Presentation with Quipper Philippines on the Free Trial of the Quipper Online Learning Management System (LMS) to introduce the platform and explore its potential use in supporting teaching, learning, assessment, and learner engagement on September 7, 2026, 2:00 P.M. at the SDO Mini-Conference.
