2. All personnel are reminded to **exercise caution and verify the identity and authority of individuals** who claim to represent DepEd officials, particularly through phone calls or other informal means of communication.
3. Please be advised that Undersecretary **Wilfredo E. Cabral does not and will not personally call DepEd personnel to demand money, request personal or financial information, or threaten them with employment-related consequences due to alleged complaints or financial obligations.** Any person making such calls while claiming to represent the Undersecretary is not authorized to do so.
4. All concerned are advised **not to provide personal or financial information or comply with unauthorized demands** and to immediately report suspicious communications to the appropriate office.
5. Immediate dissemination and compliance with this Memorandum are directed.

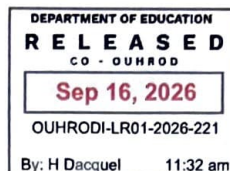
